SUBJECT: US Measles Total Climbs to 206 Cases

The North Carolina Immunization Branch, in conjunction with the Centers for Disease Control and Prevention (CDC) is issuing this release due to a recent increase in the number of measles cases nationwide. CDC has reported 206 cases occurring in 11 states since the first of the year as of February 28, 2019. For comparison, CDC reported a total of 372 cases for all of 2018, the highest number of cases since 2014. Current affected states are California, Colorado, Connecticut, Georgia, Illinois, Kentucky, New Jersey, New York, Oregon, Texas, and Washington. Five outbreaks (defined as 3 or more linked cases) have been reported in Rockland County, New York; Monroe County, New York; New York City; Washington; Texas; and Illinois. Of these outbreaks, two are still ongoing from 2018. NC reported three cases in 2018 and has reported none so far for 2019.

Measles is a highly contagious viral disease. Measles can spread when it reaches a community in the U.S. where groups of people are unvaccinated. It remains an important cause of death among young children globally, despite the availability of a safe and effective vaccine. This communication intends to serve as a reminder that vaccination against measles is the best way to prevent the spread of disease. CDC urges healthcare professionals to ensure that all patients are up to date on MMR vaccine, including before international travel.

What Should Clinicians Do?

- Discuss the importance of MMR vaccine with parents. Listen and respond to parents' questions. When parents have questions, it does not necessarily mean they will not accept vaccines, sometimes, they simply want answers to their questions.
- Ensure all patients are up to date on measles, mumps, rubella (MMR) vaccine:
 - Children need 2 doses of MMR: one dose at 12-15 months and another dose at 4-6 years.
 - Before any international travel, infants 6-11 months need 1 dose of MMR vaccine, children 12 months and older need 2 doses separated by at least 28 days, and teenagers and adults who do not have evidence of immunity against measles need 2 doses separated by at least 28 days.
- Consider measles in patients presenting with febrile rash illness and clinically compatible measles symptoms (cough, coryza, and conjunctivitis), and ask patients about recent travel internationally

or to domestic venues frequented by international travelers, as well as a history of measles exposures in their communities.

- Promptly isolate patients with suspected measles to avoid disease transmission and immediately report the suspect measles case to the health department.
- Obtain specimens for testing from patients with suspected measles, including viral specimens for genotyping, which can help determine the source of the virus. Contact the local health department with questions about submitting specimens for testing.
